

One You Hounslow Stoptober 2018 competition rules

1. No purchase necessary to join the competition.
2. The prizes in this competition are available to anyone over the age of 18 years who lives or works in the London Borough of Hounslow.
3. The competition will run from Monday 1st October until Wednesday 31st October 2018.
4. Prizes must be claimed by Friday 21st December 2018.
5. Maximum of 1 prize per person.
6. The winners will be the first five people who have set a quit date between 1st October and 31st October 2018 and have successfully stopped smoking for at least 4 weeks with the support of a One You Hounslow drop in clinic. The winners must have had carbon monoxide breath validation tests for 4 consecutive weeks showing that they are a non-smoker. The winners will all be people that have consented to be part of this competition.
7. All prizes are awarded on a first come first served basis.
8. The prizes are: 2 x adult cineworld vouchers (one prize), 2 x adult bowling vouchers (one prize), 1 x £30 Debenhams voucher, 1 x Chanel fragrance (winner to choose male or female fragrance – kindly donated by Jade Pharmacy) 1 x activity tracker

In the event of unforeseen circumstances, the Promoter reserves the right (a) to substitute alternative prizes of equivalent or greater value and (b) in exceptional circumstances to amend or foreclose the promotion without notice. The winner must claim their prize within 14 working days of the Promoter sending notification.
